

### DeKalb County Schools Capital Improvements Plan

## Direction and Status of CIP December 2008

This report summarizes the DeKalb County School System's Capital Improvements Plan through December 31, 2008. The report is organized around the Superintendent's and the Board of Education's mission and goals for the county's school system.

#### MISSION

The mission of the DeKalb County School System is to form a collaborative effort between home and school that maximizes student's social and academic potential preparing them to complete in a global society.

#### GOALS

- ✓ To narrow the achievement gap and improve the graduation rate by creating a high performance learning culture in all schools and sites.
- ✓ To increase rigor and academic achievement in Reading/Language Arts, Mathematics, and Social Studies in Pre K-12.
- To ensure the quality personnel in all positions.
- ✓ To ensure fiscal responsibility in order to maintain safe and healthy learning environments that support academic programs, resources and service.

#### This Month's Feature:



This rendering represents the North Elevation of the new Clarkston High School Career Technology Addition, designed by Harper Aiken Donahue & Partners Architecture, Inc. This Multi-level addition will include a 500 Seat Auditorium, an Orchestra Room, a Multi-family and Consumer Science Suite, a Health Occupations Suite, an Ultra Modern Pro-start State of the Arts Kitchen, an Information Technology Lab, a Band Suite and Key Board Lab, a Drama Suite, an Administrative Conference Room, and a Special Education Independent Living Suite. This project will also include Restroom Renovations, Light Fixture Upgrades, interior painting throughout the facility, and various site improvements.

#### IMPLEMENTATION

#### Deferred SPLOST II Work

Southwest DeKalb High School: Exterior brick installation for the Multi-purpose Building is 100 percent complete along with installation of CMU, door frames, plumbing rough-in, and electrical rough-in. Installation of the Multi-purpose Building high bay lights and storm water line is also complete. HVAC installation has commenced and is scheduled for completion in January 2009. Substantial completion for this project is tentatively scheduled for January 2009.





• Towers High School: Tennis court construction activities that consisted of the removal of two existing tennis courts, the construction of two new tennis courts, the installation of vinyl coated perimeter fencing, new double braided tennis court nets and nylon center straps and ground anchors are 100 percent complete. Installation of the telescopic bleachers is also complete.

• Columbia High School: Construction work in the Cafeteria, Media Center, Gymnasium lower level, and Consumer Science Center is approximately 100 percent complete. Construction activities have commenced on the Fine Arts Building. The Fine Arts Building and associated sports amenity areas (i.e., practice field, baseball dugout area, etc.) are scheduled for substantial completion by July 2009.



 McNair High School: The Deferred Work at McNair High School includes the construction of a new dual baseball/softball field, resurfacing of the tennis courts, new sod at the practice field, an ADA access ramp to the playing fields, a new ADA access ramp at the auditorium, and repairs to the exterior of the gymnasium. Merit Construction Company will commence with construction

activities at the project site once the construction contract is finalized by Dekalb County School System and the Land Disturbance Permit is obtained. The Land Disturbance Permit is anticipated to be issued on or around January 31, 2009.

### Other Projects in Construction


• Tucker High School: The Land Disturbance Permit for this project was received on November 19, 2008. Construction work on the Outbuilding is 100 percent complete. The Certificate of Occupancy was issued on November 25, 2008. Building Permit Drawings were submitted by the General Contractor to the Dekalb County Planning and Permit Office for subsequent review and approval. The General Contractor commenced tree removal along the property line in November 2008. Tree removal activities were completed in December 2008. The Contractor has completed the installation of the storm water line along the existing running track and sewer lines near the Outbuilding.



Contractor has also completed the installation of the new water vault near the bus entrance. Substantial completion for this project is scheduled for December 30, 2010.



- Mountain Industrial Center (Phase II): Work is progressing as scheduled at the Mountain Industrial Center. The Cafeteria and Kitchen areas are approximately 80 percent complete. All kitchen equipment has been installed along with freezers and the HVAC system. The interior finishes and electrical scope of work is also complete. The 80 percent Fire Marshal Inspection has also been completed. The installation of the sanitary sewer line at the facility is currently in progress. The preliminary Department of Energy review is complete for the Open Campus High School project and the permit has been approved.
- Sam Moss Service Center: Overhead supply and return ductwork is approximately 80 percent complete. All in-wall electrical conduit and wiring is 90 percent complete. Voice and data low voltage wiring is in progress. Installation of gas piping is currently in progress. Electrical floor and wall cover-up inspections as well as wall framing inspections were completed in November 2008. The plumbing in-wall rough-in inspection was also completed in November 2008. The installation of sheetrock for Phase I is 100 complete. Substantial completion for Phase I is anticipated during the first quarter of 2009.

• Woodward Elementary School: The construction activities at Woodward Elementary School consists of the installation of eight temporary classroom trailers, removal and replacement of existing ceiling and lighting, removal and replacement of select ductwork and water source heat pumps, and installation of new DDC Controls. The contractor has received the Building Permit for temporary classroom trailer installation. Student and faculty equipment and materials were relocated to temporary classroom trailers during the winter break. Phase I demolition activities and the installation of ductwork and ceiling tiles are approximately 50 percent complete. Substantial completion for Phase I is scheduled for February 28, 2009.

### **Roofing Projects**

- Rainbow Elementary School: The construction work at Rainbow Elementary School commenced on November 24, 2008. The contractor has completed the demolition of the existing roof and has installed the vapor barrier. Substantial completion for this project is anticipated on March 31, 2009.
- Heritage Center: Construction activities at the Heritage Center commenced on November 24, 2008 and are progressing ahead of schedule. All roofing materials were delivered to the project site on December 6, 2008. Substantial completion for this project is anticipated on February 5, 2009.
- Sagamore Hills Elementary School: Construction activities commenced at Sagamore Hills Elementary School on November 11, 2008. Roof demolition activities are 100 percent complete. Installation of roof insulation and roof base sheet is approximately 50 percent complete. Substantial completion is scheduled on April 21, 2009.

### **Local School Priority Request Projects**

• Stephenson High School *Track Replacement and Site Repairs:* This project consists of the replacement of the running track with a new rubberized track surface, repair and/or replacement of the drainage system surrounding the track, installation of new in-field netting along first and third base lines at the baseball field, and replacement of outdoor carpet in the batting cages. Final design was approved by Dekalb County School System on November 25, 2008. The Notice to Proceed was issued to the contractor on December 4, 2008. Substantial completion is scheduled for May 18, 2009.

### **Technology**

• Refresh: The purpose of this project is to install 7,500 workstations throughout the Dekalb County School System. Each school will receive an equitable amount of workstations based on student enrollment, class size maximums, and available budget. As of December 2008, a total of 6,476 workstations have been installed in 116 schools.

#### Buses

• Group 1: To date, all thirty-six buses have been received. All pre-delivery inspections are completed and ten general school buses were on the road as of October 2008. The remaining 26 Special Needs buses were received in early November 2008 and are in operation.

### **Projects in Closeout**



- Mountain Industrial Center (Phase I DECA Program): All work has been completed on the new facility for the DECA program. All Close-out documents have been transmitted from the contractor to Dekalb County School System for review. Close-out is scheduled to be completed by January 31, 2009.
- Sky Haven Elementary School: Sky Haven Elementary School's Roof Replacement project is approximately 100 percent complete. This project is currently being closed out.
- Murphy Candler Elementary School: Murphy Candler Elementary School's Roof Replacement project is approximately 100 percent complete. This project is currently being closed out.
- Brockett Elementary School HVAC Make-Up Air: Installation of the HVAC units, ductwork, and controls commenced on December 20, 2008 and was completed on December 31, 2008. This project is currently being closed out.
- Stephenson Middle School: The controllers on the RTUs have been installed and are operational. This project is 100 percent complete and is currently being closed out.
- Henderson Middle School Classroom and Restroom Upgrades: All work has been completed and the project is currently in close-out.
- Lithonia Middle School: Replace carpet in the Band Room. Carpet installation is complete and the project is currently in close-out.
- Salem Middle School Replace Chalkboards with Whiteboards: Replacement of all chalkboards with dry erase boards has been completed. This project is currently being closed out.
- Smoke Rise Elementary School Replace 20 Classroom Dry Erase Boards: The replacement of twenty classroom dry erase boards has been completed. The project is currently being closed out.
- Glen Haven Elementary School Replace Bathroom Sinks and Toilets and Replace Media Center Carpet: The replacement of all the sinks and toilets in the Restrooms has been completed. The

replacement of carpet in the Media Center was completed over the winter break. The project is currently being closed out.


- Gresham Park Elementary School Replace Media Center Carpet: The replacement of carpet in the Media Center was completed over the winter break. This project is currently being closed out.
- Idlewood Elementary School: Replace carpet in Principal's Office, Front Office, Media Center and Assistant Principal's Office. Carpet installation is complete. The project is currently being closed out.

### **Projects in Design**

- Cross Keys High School: Renovation and Relocation of the Dekalb High School Technology North Program: Notice of Award has been issued to MEJA Construction for the new addition and associated site work. Architectural design is ongoing with expected Department of Education drawings to be submitted by the end of January 2008. Request for Proposal for Material Testing, NPDES monitoring, and Special Inspections have been reviewed and approved by Dekalb County School System.
- Stone Mountain High School: HVAC, Ceiling, and Lighting Replacement and Roof Replacement: Leppard Johnson and Associates have submitted their 95 percent Construction Documents for the HVAC, Ceiling, and Lighting Replacement project. These documents are currently being reviewed by DeKalb County School System. The Preliminary Design Submittal on the Roof Replacement work was submitted and DeKalb County School System's review comments are currently being incorporated into the design.
- Redan High School: HVAC, Ceiling, and Lighting Replacement, Roofing Replacement, & Career Technology Addition: The 100 percent Construction Documents have been received by Warren Epstein & Associates. Pre-Proposal, Site Visit, and RFP Due date listed in the Advertisement for RFP and the RFP Documents for this project are being rescheduled.

- Midvale Elementary School: HVAC, Ceiling, and Lighting Replacement, ADA modifications, and Roof Replacement project: This project is designated as a Design/Build project. An RFP for Design/Build Services was promulgated for subsequent response by bidders. The RFP responses were received in November 2008 and are currently being evaluated by Dekalb County School System.
- Cedar Grove High School: HVAC, Ceiling, and Lighting Replacement: Dekalb County School System has received and reviewed the 75 percent Construction Drawings submitted by BAA Mechanical Engineers. Preliminary Roof Design Drawings and Specifications were received on November 5, 2008. Review comments were provided by DeKalb County School System in December 2008 and are currently being incorporated.
- Clarkston High School: Career Technology Addition and Facility Improvements: The Architectural firm, Harper Aiken Donahue & Partners Architecture, Inc., has made a preliminary submittal to the Department of Education for approval. Comments have been received and are being incorporated into the next submittal for Dekalb County School System review.



• Druid Hills High School: Facility Renovation and Addition: The Land Disturbance Permit was executed on December 10, 2008 by Dekalb County School System and returned to Dekalb County's Permitting Office for issuance. Final civil design, water and sewer, and fire drawings have been approved. Request for Proposal for Material Testing, NPDES monitoring, and Special Inspections have been reviewed and approved by Dekalb County School System. Final installation

of the WAN fiber optic line is complete. Installation of the storm water drain line is in progress along with the relocation of the temporary bus lane. This project is scheduled for Substantial Completion on July 10, 2010.

- Dunwoody High School: HVAC, ADA, Career Tech Renovation and Additions: A Community Meeting to discuss the status of the project took place in November 2008. Preliminary Construction Documents were submitted to the Department of Education in November 2008 and were approved on December 5, 2008. A Design Team Meeting took place in December 2008 with Dunwoody High School staff and administration to review the updated design and plans. Additional concrete and rebar testing services by GeoHydro Engineers were approved by DeKalb County School System on December 22, 2008 and testing is anticipated to commence the first week in January 2009.
- DSA Relocation: *Dekalb School of the Arts Relocation:* This project is currently being designed by Warren Epstein & Associates. The Civil and Structural design is 100 percent complete. The Civil design and specifications were submitted to Dekalb County Permitting Office on December 15, 2009 for a Land Disturbance Permit. The design is scheduled for completion in March 2009.
- Lakeside High School: Career Technology Addition and ADA Modifications: A recommendation was made to the Board of Education for approval at the November 2008 Board of Education Meeting. Manley Spangler Smith Architects was approved by the Board of Education to provide design services on this project. An executed contract is anticipated by January 2009.





### **Roofing Projects**

The second mission of infrared roof scans was flown in September 2008. The first reports were delivered on November 5, 2008.

- Sequoyah Middle School, Clarkston Center, and Champion Theme Middle School: *Roof Replacement:* The 90% Completion of Design for Construction and final price estimate are being reviewed by Dekalb County School System. The 100% Design for Construction documents have been received and are currently being reviewed by DeKalb County School System.
- Wadsworth Elementary School and Avondale Elementary School: *Roof Replacement:* The 100% Construction Documents have been received. Pre-Proposal, Site Visit, and RFP Due date listed in the Advertisement for RFP and the RFP Documents for this project are being rescheduled.
- Eldridge Miller Elementary School: Roof Replacement: PCI Group, Inc. was selected to provide design services on these projects. An executed contract is anticipated in January 2009.
- Terry Mill Elementary School, Nancy Creek Elementary School, Midway Elementary School, and Dekalb High School of Technology South: PCI Group, Inc. was selected to provide design services on these projects. Design services will commence upon the completion of an executed contract by DeKalb County School System. An executed contract is anticipated in January 2009.

### **Local School Priority Request Projects**

#### First Quarter 2008

- Nancy Creek Elementary School and Montgomery Elementary School: *Parking Lot Additions:* Merit Construction Company has been awarded both projects. The Design/Build contracts have been completed. Design work is anticipated to commence in January 2009.
- Terry Mill Elementary School: *DESA Relocation:* Sheffer & Grant Architects submitted their Preliminary Report to Dekalb County School System in September for the relocation of the DeKalb Elementary School of the Arts to Terry Mill Elementary School. A Community Meeting was held on November 20, 2008. The Design is currently in progress. Seventy-five percent Construction Documents are anticipated in January 2009.
- Marbut Elementary School and E. L. Bouie Elementary School: *Multi-purpose Building Restroom Additions*: A preliminary evaluation of the scope of work necessary to complete the addition of restrooms to the Multi-purpose Buildings at Marbut Elementary School and E. L. Bouie Elementary School has been completed. A RFP for design/build services was issued and a mandatory preproposal conference and site visit was held with all interested bidders. Bids were received on November 11, 2008. A recommendation to select a contractor will be presented to the Dekalb County Board of Education in January 2009.

### Second Quarter 2008

Assessments were completed in September to develop the scopes of work for all projects approved in the Second Quarter Local School Requests. The projects to be completed are as follows:

- Vanderlyn Elementary School: Repair/Replace Restroom Sinks, Commodes, and Stalls: Scope of work was reviewed by Dekalb County School System.
- Huntley Hills Elementary School: Renovate All Restrooms: Scope of work was reviewed by Dekalb County School System.
- Margaret Harris High School: Resurface Parking lot; Clean, Repair, and Paint Various Areas: Repair Fencing/Gate; Repair toilet Structure; and Replace Washers and Dryers: The development of the scope of work is complete for the resurfacing of the main parking lots and wheel chair ramps; installing of new guard rails; cleaning, repairing, and painting of areas within school building; repairing fencing, gates, and add locking mechanism; repairing toilet structures and purchasing two washers and dryers. An invitation to bid for the parking lot resurfacing has been issued.
- Henderson Middle School: *Kitchen Tile Repair/Replacement*: The repair and/or replacement of uneven tile in the kitchen area near the refrigerator was scheduled to commence during the winter break. However, due to floor temperature concerns for proper installation of grout in this area, the project has been rescheduled. Work is anticipated to commence during the first quarter of 2009.
- Sam Moss Center: Bus Driver Aisle Repair and Repaving: Specifications are complete and are currently being reviewed by Dekalb County School System.
- Multiple High Schools: *Outdoor Security Lighting*: The addition of outdoor security lighting is complete at Lakeside and Cedar Grove High School. The installation of outdoor security lighting is underway at Avondale and Clarkston High School. The remainder of outdoor security lighting installation at select Dekalb County High Schools is scheduled for completion in early January 2009.
- Idlewood Elementary School: Additional Parking Lot: The Board of education approved the award of a Design/Build Contract to Baldwin Paving. The Design/Build Contract is currently being reviewed by Dekalb County School System.

#### Third Quarter 2008

The Board of Education approved the Third Quarter Local School Requests at the October 2008 Meeting. Assessments are on-going to develop the scopes of work for all projects approved. The projects to be completed are as follows:

- Kingsley Charter School: Purchasing new Media Center tables and chairs.
- Eagle Wood Academy: Replace windows and some blinds throughout building; repair doors and install new locks. The scope of work is currently being reviewed by Dekalb County School System.
- Laurel Ridge Elementary School: Replace blacktop for Parking Lot and Tennis Courts.

- Oak Grove Elementary School: Divert downspouts to the existing storm drains and Install 200' of fencing.
- Multiple Locations: Install Basin Heaters.
- Multiple Locations: Install 94 Emergency Generators.

### Americans with Disabilities Act (ADA) Projects

The objective of the CIP ADA Projects is to increase accessibility for mobility-impaired individuals at our school sites. Issues to be addressed at each site include access to the main entrance, access to playing fields and playgrounds, access to the Multi-purpose Building (gym) at our elementary schools, and access to restrooms.

Dekalb County School System's project management team evaluated existing ADA reports and prepared the CIP ADA Projects Plan. This plan was completed in July 2008 and contained five "bundles" of school sites grouped A through E. These "bundles" were based on scope of work and proposed tentative schedules of completion for each.

• There are nineteen facilities included in Group A Projects which are Bob Mathis Elementary School, E. L. Miller Elementary School, Idlewood Elementary School, Kingsley Elementary School, Avondale Elementary School, Laurel Ridge Elementary School, Ashford Park Elementary School, Livsey Elementary School, Panola Way Elementary School, Allgood Elementary School, Flat Shoals Elementary School, Fernbank Elementary School, Indian Creek Elementary School, Cedar Grove Elementary School, Columbia Elementary School, Glen Haven Elementary School, Gresham Park Elementary School, Hightower Elementary School, Kelley Lake Elementary School and Champion Theme Middle School.

These schools are slated to receive exterior improvements such as refurbishing the ADA parking areas, installing curb cuts and/or on-grade accessible routes and installing ADA compliant ramps. Group A bids have been received and a recommendation for award for sixteen of the nineteen schools was made to the Board of Education at the November 2008 Meeting. Contract and award recommendations are currently being reviewed. Construction Contracts will be awarded following Board of Education approval. Emergency restroom accessibility renovation has been completed at Champion Theme Middle School.

• There are eleven facilities included in Group B are Austin Elementary School, Brockett Elementary School, Medlock Elementary School, Montclair Elementary School, Peachcrest Elementary School, Rainbow Elementary School, Rock Chapel Elementary School, Smoke Rise Elementary School, Midway Elementary School, Sky Haven Elementary School, and Woodridge Elementary School.

Group B Projects: Site surveys for Group B schools were performed between July 22 and November 14, 2008. These schools are slated to receive exterior improvements such as refurbishing the ADA parking areas, installing curb cuts and/or on-grade accessible routes and installing ADA compliant ramps, and installing ADA compliant restrooms. The preliminary bid packages are complete and are being reviewed by Dekalb County School System.

### **SCHEDULE**

The DeKalb County School System hired Project Service Group in April 2008 to update the overall program schedule. The Design & Construction Department received a draft of the schedule in July. The updated program schedule and cash flow analysis is pending until the final revised program schedule is completed. Below is a complete Capital Improvements Plan project listing which includes the anticipated construction delivery method and the status of the project.




