Atlanta Environmental Management, Inc. (AEM) is pleased to provide the DeKalb County School District (DCSD) an electronic copy of the Lead in Drinking Water Sample Results for Hambrick Elementary School (Facility ID #3057). Samples were collected on December 16, 2016, and analytical results were received from Analytical Environmental Services, Inc., on January 9, 2017.

FINDINGS

AEM collected 64 drinking water samples from 32 sources at Hambrick Elementary School (Facility ID #3057), including two duplicate samples. A description of the drinking water outlets sampled and a summary of sample analytical results are provided in the attached table.

One of the sources sampled had a drinking water sample result that contained lead at a concentration at or above EPA's action level of 15 parts per billion. This source is indicated in bold and shaded font in the attached table.

Atlanta Environmental Management, Inc. (AEM) is pleased to provide the DeKalb County School District (DCSD) an electronic copy of the Lead in Drinking Water Sample Results for Hambrick Elementary School (Facility ID #3057). Additional drinking water samples from select source units were collected on October 20, 2017, and November 17, 2017, and analytical results were received from Analytical Environmental Services, Inc., on October 30, 2017, and November 21, 2017.

FINDINGS

Sample Results of Previously Identified Source Units That Exceeded 15 ppb

During the initial sampling event on December 16, 2016, one source unit (KS-002) was sampled and the analytical results indicated that the results were above EPA's action level of 15 ppb. DCSD replaced the source unit and AEM collected two drinking water samples on October 20, 2017. A description of the drinking water outlet sampled and a summary of sample analytical results are provided in Table 1.

One or more of the samples from source unit KS-002 had a drinking water sample result that contained lead at a concentration at or above EPA's action level of 15 ppb. Source unit KS-002 remained out of service so that additional remediation measures could be evaluated.

A filter was added to the bubbler of KS-002 and retesting was conducted on November 17, 2017. None of the samples collected from KS-002 contained lead at a concentration exceeding EPA's action level of 15 ppb.
